Opponents denounced the idea as card check by other means. National Right to Work Foundation President Mark Mix warned, "[M]uch like card check organizing, electronic voting leaves the door open to coercion and identity theft, and will be used by aggressive union organizers to impose forced unionism on more workers."

Solomon Will Recommend 'New Framework'For NLRB Deferral to Arbitration Procedures

In a memorandum to the board's regional offices (Memorandum GC 11-05), Solomon said that after a review of deferral cases under the NLRA, he concluded that in cases brought under Section 8(a)(1) and 8(a)(3) of the act, "the Board should no longer defer to an arbitral resolution unless it is shown that the statutory rights have adequately been considered by the arbitrator."

Obama Creates New Jobs Council To Put U.S. Economy Into 'Overdrive'

President Obama Jan. 21 said he is creating a new Council on Jobs and Competitiveness headed by Jeffrey Immelt, chairman and chief executive officer of GE, with the goal of speeding up the nation's economic recovery.

But Scott Paul, executive director of the Alliance for American Manufacturing, a laborbacked advocacy organization, called Immelt a poor choice. "There is no swifter way to alienate working class voters than to name an outsourcing CEO to lead your jobs strategy," he said in a statement.

New Faces Appear at Bargaining Table

State might limit public unions

Republican state lawmakers soon might introduce legislation that would ban local governments from negotiating collective bargaining agreements, a move that would effectively neutralize the unions that represent South Dakota's teachers and other public-sector employees.

If such legislation would pass, union officials no longer would be able to negotiate contracts on behalf of their members. Republicans say they are considering the measure because unions in other parts of the country have driven up pension costs and created unsustainable salaries. GOP leaders say they don't want that to happen in South Dakota.

NLRB Sets Hearing on NUHW Objections To Kaiser Election Among 45,000 Employees

Last month, an NLRB administrative law judge ruled that Southern California Permanente Medical Group and Kaiser Foundation Hospitals violated the National Labor Relations Act by withholding the scheduled wage increase and making unilateral changes in worker benefits (239 DLR AA-1, 12/14/10). Several days later, a federal district court granted an NLRB request for a Section 10(j) injunction and ordered the two Kaiser entities to grant the employees prospectively the withheld wage increase and to rescind the other unilateral contract changes they made (243 DLR A-1, 12/20/10).

Postal Service Eyes Closing Thousands of Post Offices

Now, with the red ink showing no sign of stopping, the postal service is hoping to ramp up a cost-cutting program that is already eliciting yelps of pain around the country. Beginning in March, the agency will start the process of closing as many as 2,000 post offices, on top of the 491 it said it would close starting at the end of last year. In addition, it is reviewing another 16,000—half of the nation's existing post offices—that are operating at a deficit, and lobbying Congress to allow it to change the law so it can close the most unprofitable among them. The law currently allows the postal service to close post offices only, for maintenance problems, lease expirations or other reasons that don't include profitability.
