The National Right to Work Committee has launched a \$100,000 ad campaign pushing Republicans to rescind the very first concession they made: consigning a right-to-work bill to a summer study committee.

Even before the walkout, Governor Daniels had urged Republicans not to advance the bill outlawing mandatory union dues, arguing the GOP hadn't campaigned on it, and accurately warning it could disrupt the legislative session.

Election Officer Orders Hoffa Slate to Cease Using IBT Resources for Campaign Activities

The election supervisor overseeing the International Brotherhood of Teamsters' election of officers March 14 ordered the campaign of IBT President James P. Hoffa and each candidate on his slate to cease and desist from using union resources to conduct campaign activity.

Election Supervisor Richard W. Mark directed the campaign specifically to cease and desist from offering any job or benefit where the "offeror has the authority at the time to consummate the offer and the offer is made solely in exchange for partisan political activity or is designed solely to create electoral advantage for the incumbent appointing officer and his or her campaign or slate of candidates for union office."

CWA, AFL-CIO Praise AT&T Acquisition Of T-Mobile USA With Organizing Neutrality

AT&T would follow its practice used in all previous acquisitions to ensure true management neutrality regarding employee collective bargaining rights, allowing workers to make their own choice about union representation, CWA spokeswoman Candice Johnson told BNA March 21. At AT&T Mobility, as AT&T acquired new companies, workers have chosen union representation through several different election processes in about 300 events, she said.

AT&T noted that it is the only major U.S. wireless company with a unionized workforce. The combined company would continue to have a strong employee and operations base in the Seattle area, AT&T said March 20 in a statement.
