# Right to Work Laws Defended, Attacked In Wake of NLRB ULP **Charge Against Boeing**

Patrick Semmens, director of legal information at the National Right to Work Legal Defense Foundation, a group that favors right to work laws and, according to its website, offers "free legal aid to employees whose human or civil rights have been violated by abuses of compulsory unionism."

In addition to providing "strong economic benefits" to both state governments and workers in right to work states, Semmens said right to work laws "make unions better in terms of representing their employees," because the unions then must "earn workers' dues for the services they provide."

Semmens added that workers in non-right to work states who do not belong to unions are more frequently fired for reasons related to union membership than those in right to work states. "We represent employees choosing between being fired and paying dues to a union," he said.

# GRAY: NLRB takes unconstitutional stance on Boeing's expansion

In Teamsters Local 251, 356 NLRB No. 135 (2011), the Board recorded a welcome win for employers, holding that the union violated the National Labor Relations Act when it demanded that a construction contractor comply with an agreement not to use the services of two nonunion trucking companies to haul construction materials to its jobsite, and when it engaged in a strike against the contractor to enforce that agreement.
